ANNOUNCEMENTS

Council extended a warm welcome to the Town's new Chief Administrative Officer, Mr. Rob Beaupertuis. Rob will lead our administration in delivering Council directives set for the Town, while ensuring that the Town remains compliant with all legislation pertaining to municipalities in the province of Newfoundland and Labrador.

Council extended congratulations to Jared Picco for making the 2021 U14 Provincial Softball Newfoundland and Labrador team and Kaitlyn Sweeney who was selected for the NL U22 Female Canada Games Softball team.

EXPENDITURE HIGHLIGHTS

Highlights of Council expenditures included:

- \$14,347.84 plus HST as the Town's portion towards COVID Stimulus Program for upgrades to the Public Works Facility on a 90/10 Provincial/Community cost-shared basis.
- \$1,080 for renewal of Travel Accident Policy from Cal LeGrow
- \$1,324.80 for installation & balancing of tires for F350 truck
- \$1,428.30 for water treatment supplies
- \$3,444.48 for annual renewal of email apps business accounts
- \$1,610 for 14-hour rental of semi dump truck to transport salt from Point Verde to Argentia
- \$2,309.20 for professional services rendered for grievance hearing
- \$17,361.50 for first quarter assessment fees by Municipal Assessment
- \$1,265 for shipment of water supplies in November
- \$1,630.70 for shipment of water supplies in December
- \$1,524 including HST for emergency electrical repairs to O'Reilly Street lift station.
- \$6,863.07 for software licencing.
- \$25,731.25 for motor replacement at Placentia Pumphouse

- \$11,261.38 for heavy equipment rental from August to October 2020
- \$3,660.70 including HST for maintenance to Town owned generators
- \$2,500 (not to exceed) to acquire a survey of the convent land

FIREWORKS

The Town's Community Fireworks Display was a success and thanks were extended to the Fire Department and Tourism Department. Family fireworks were frequent during the days around New Years and are becoming an issue. The option of the Town creating a bylaw for the use of fireworks during a specific timeframe was discussed. Flares were also being set off in the Town over the holidays. This misuse of flares is illegal, and the matter will be forwarded to the RCMP.

PLACENTIA WINTER CARNIVAL

ANIMAL CONTROL

The issue of roaming dogs in Dunville continues to be pursued by the Municipal Enforcement Officer; however, current bylaws restrict the Town's authority to resolve the issue. Current bylaws will be reviewed and required amendments will be made. Residents are reminded to keep their dog licenced and to call the Town's emergency line, 227-4314 or 227-4316, for issues after 5:00 pm or during weekends.

RETURN TO PLAY

Staff are remaining vigilant and are continuing to follow guidelines and rules in place at the arena. Safety remains the number one priority. Participants up to the age of 18 are now permitted two parents/guardians to accompany them into the facility for any practices and games. Note that the renter is still responsible for ensuring that those who are in the building are registered on the declaration Form. Council supports all decisions of management regarding the return to play document. COMMUNICATIONS EQUIPMENT

The Town's existing equipment for live recording is outdated and needs to be upgraded. The Manager of Tourism, Marketing and Communications will seek advice on improvements to the system before referring to appropriate Committees for funding approval and tender documents.
